1. PURPOSE OF THE REQUEST FOR QUOTATIONS

- 1.1 ATNS invites experienced and qualified suppliers to submit quotations for the Design, supply, construct and set to use custom-made free-standing executive change cabinet.
- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe and cost-effectiveness for ATNS.
- 2. EXTENT OF WORK
- 2.1 SCOPE OF WORK

Executive Change Cabinet

Design, supply, construct and set to use custom-made free-standing executive change cabinet.

Work Specific Requirements

Design, supply, construct and set to use bespoke free-standing executive change cabinet that conforms to the following;

1. Overall Dimensions

3. Color and Finishing

The cabinet shall comply with Midnight/Black Stone with matt finish.

4. Electrical Requirements

LED Lighting: Compartments listed under 2 shall be illuminated by LED Lighting. Electrical Wiring shall be concealed.

5. Other Accessories

The following are to be supplied as part of the design, supply and construction;

- a. Concealed mirrors
- b. Hangers
- c. Chrome plated die cast zinc 90 degree RH/LH cam action lock with key. The lock shall be IP54 rated. All the locks shall use a single key. 5 spare keys are to be supplied.

6. Quality Control Measures

Survey and Measurements: A Survey shall be conducted to ascertain the cabinet measurements and installation requirements.

Design: An allowance for CAD or Equivalent design shall be made. Provisions for 5 iterations shall be made. Manufacturing shall not commence without written approval from the client.

Material Sampling: Materials shall be submitted to the client for approval before manufacturing.

Factory inspection: Factory inspection shall be conducted prior to delivering to site. The client will not be taking delivery without factory inspection and written approvals. The factory inspection is to ascertain conformance to the client accepted design. Installation inspection: Work shall be inspected and approved after installation on site.

7. Warranty and Design life

The executive change cabinet shall comply to a 10-year warranty and design life.

8. Documentation and Control

Documentation to be generated as part of the contract shall be the responsibility of the contractor.

Inspections will be carried out by the ATNS representative in order to ensure that the works is carried out to satisfaction and in line with the Work Specification and the method statement provided by the Tenderer and accepted by ATNS.

a. SAFETY (IF SUPPLIER IS GOING TO WORK AT THE AIRPORT)

On appointment the successful tenderer must submit a SHE file complying with the latest amendment of the Occupational Health and Safety Act and Regulations.
