### 1. PURPOSE OF THE REQUEST FOR QUOTATIONS

- 1.1 Air Traffic and Navigation Services SOC (herein this document referred to as "ATNS") seeks to identify and appoint suitable supplier for the appointment of a service provider for Luanda Vsat installation services at the new Luanda airport Dr. Antonio Agostinho Neto International Airport.
- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe, and cost-effectiveness for ATNS.

### 2. EXTENT OF WORK

### 2.1 SCOPE OF WORK

The successful service provider will be required to perform the following services: Installation, testing and commission of SADC/2 and Luanda local VSAT terminals.

The evaluation of responsive quotations shall be conducted by the ATNS SCM and Engineering Projects following a four-stage process as follows:

# Inspections

# 2.2 SAFETY (IF SUPPLIER IS GOING TO WORK AT THE AIRPORT)

### 2. **DEFINITIONS**

- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
