1. PURPOSE OF THE REQUEST FOR QUOTATIONS

- 1.1 ATNS invites experienced and qualified suppliers to submit quotations for repair damaged the palisade wall, repair damaged electric fence and mount a gate motor and install a new gate motor track at radar site
- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe and cost-effectiveness for ATNS.

Replace 3x 2.4m high concretepalisade wall sections and panel bricks. Install 2x 2.4m high concrete palisade pillars, to match the existing design.

Tighten loose bracket for the gatemotor and replace the existing gate motor track.
