ANNEXURE A: SCOPE OF WORK

1. PURPOSE OF THE REQUEST FOR QUOTATIONS

- 1.1 Air Traffic and Navigation Services SOC (herein this document referred to as "ATNS") seeks to identify and appoint suitable supplier to provide pest control services at ATNS Bram Fischer Airport, Kimberley Airport and remote sites for a period of five (5) years.
- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe, and cost-effectiveness for ATNS.

2. EXTENT OF WORK

2.1 SCOPE OF WORK

- 2.1.1 Spray and gel for cockroaches, ants, bees and other flying insects. Bate stations and poison for mice and rats.
- 2.1.2 Provide additional pest control services on an Ad Hoc basis at remote sites.
- 2.1.3 Respond to calls logged for any pest control requests.
- 2.1.4 Use environmentally friendly products to spray for crawling and flying insects including rats
- 2.1.5 All pest control units are to be of good quality and presentable.

2.2 Contractor's responsibilities

- 2.2.1 Fully responsible for meeting all requirements in this document regarding the works.
- 2.2.2 Ensure that all work will be carried out to standard as required by the OEM and conform to all relevant SANS and OHS act regulations and legislation.
- 2.2.3 Provide responsible and sufficiently skilled and qualified staff to execute the tasks.
- 2.2.4 Remain responsible to ensure that the staff compliment is sufficient to maintain the service levels.
- 2.2.5 Ensure that any staff member reasonably suspected of partaking in criminal activities is immediately removed from site and their permit is returned and cancelled at ACSA permit office.
- 2.2.6 Ensure that all services are performed within the required response times as stipulated on the service levels.
- 2.2.7 Ensure that all staff members are issued and able to use all relevant PPE for the services provided including reflective vest.

- 2.2.8 Ensure that the staff members know their way around the use of tools required for the works.
- 2.2.9 Ensure that No unsafe equipment or tools are brought onto or used on company premises, ATNS reserves the right to inspect all equipment and to prohibit their use at any given time.

2.3 Management

2.3.1 Planning and programming

- All maintenance work shall be scheduled according to a specific routine and not randomly interfere with ATNS office normal operations.
- Normal operational hours are from 07:00 to 17:00 Weekdays.

2.3.2 Environment

The contractor will keep noise and dust levels to a minimum. At no time shall the works result in nuisance, interference or endanger people's life.

At no time shall the Contractor: -

- Allow any pollutants or toxic substance to be released into the air or storm water systems.
- o Interfere with, or put risk, the functionality of any system or service.
- Cause fire or safety hazard.

2.3.3 Management meetings

The contractor will be expected to attend meetings relating to maintenance, operations, contract management and other issues that may arise. The contractor is required to make key personnel available for these meetings and no incentive submissions will be claimed against ATNS for attendance of such.

2.3.4 ACSA access permits

- The Contractor shall not be compensated for costs relating to ACSA required permits nor for labour and time spent obtaining it.
- The Contractor must ensure that they are familiar with ACSA safety and security requirements relating to permit in order to avoid work delays, this includes permit application process.

2.3.5 Health and safety requirements and procedures

Where the OHS Act prescribes certification of competency of persons performing certain tasks, proof of such certification shall be provided to ATNS service supervisor.

2.3.6 Protection of ATNS employees

- ATNS reserves the right to act in any way to ensure safety and security of any person, equipment or goods on its premises and will not be held liable for any cost or loss evoked by the action. This includes the right to search all vehicles and person entering, leaving the premises and to inspect any parcel or package.
- Contract will take special care not to harm or endanger ATNS staff in any way, precautionary measures will be put in place to avoid introduction of danger or any harm to ATNS staff member(s).
- At no time must the Contractor interfere with or put risk to the functionality of any fire prevention system.

2.3.7 Barricades and lighting

Where hoarding, barricades or lighting is required in the execution of the works, the Contractor shall provide such at their own expense.

2.3.8 Operational hours

ATNS Bloemfontein region normal operational hours are from 07:00 to 17:00 weekdays (Mon – Fri)

2.4 Service Levels

2.4.1 Response Times

- Contract should be able to respond within 4hours and response time will be measured from reporting to contractor.
- All calls must be completed within reasonable time preferably maximum of 4hrs, special arrangements will be made for work that requires fixed dates with ATNS service supervisor.
- ATNS will hold the Contractor liable for any costs incurred through negligence or unreasonable poor performance from the Contractor's member(s) to ATNS property.

3. GENERAL

- 3.1. Provide quoted prices which is inclusive of all items (preparation, material, labour and transport costs)
- 3.2. Provide quotation inclusive of VAT valid for 60 days.
- 3.3. The contractor shall leave area of works neat and tidy on completion.

4. DELIVERIES OF GOODS AND SERVICES

- 4.1. Deliveries must take place within 7 working days of placing an official purchase order.
- 4.2. The service provider shall always remain fully and solely responsible for the timeous delivery of service/goods to ATNS.
- 4.3. An official purchase order must be issued before any services may be rendered to ATNS.

5. QUALITY

- 5.1. Quality Standards
- 5.1.1. In the event where ATNS elects to accept an alternative item purported to be equal/similar by the tenderer, acceptance of the item(s) will be conditional on ATNS's inspection on receipt.

6. CONTRACTORS' RESPONSIBILITIES

- 6.1. The Contractor shall
- 6.1.1. Provide all the necessary skills, resources, tools, equipment and experts, to carry out the works.
- NB: The project is to run between Mon Fri 07h30 till 16h00 unless is it impossible to work within operational hours.

Inspections

Inspections will be carried out by the ATNS representative in order to ensure that the works is carried out to satisfaction and in line with the Work Specification and the method statement provided by the Tenderer and accepted by ATNS.



SAFETY (IF SUPPLIER IS GOING TO WORK AT THE AIRPORT)

On appointment the successful tenderer must submit a SHE file complying with the latest amendment of the Occupational Health and Safety Act and Regulations. The contractor will only be issued with a site access certificate once his SHE file has been approved and accepted by ATNS. It is therefore of utmost importance that the SHE files gets approved before any delivery to site is considered, to prevent unnecessary delays and standing time at the Airport entrance gate.

Minimum site SHE file requirements (also refer to OHS Act and Regulations):

- Site specific risk assessment
- · Site specific method statement
- Waste Management Plan
- Valid medical certificate of fitness for all employees on site, issued by an occupational health practitioner
- Environmental Method Statement
- Proof of Competency for the duly appointed competent staff on site
- Records of the health and safety induction training pertaining to the site
- ID copies for employees on site
- The PPE register for the site essential PPE, i.e., life jackets, safety harness, etc., issued to employees on site
- Letter of good standing with the Department of Labour in terms of the Compensation fund
- Any other certificates relevant to the site and activities to be carried out

The successful tenderer will be responsible for the site to be in a safe and tidy condition throughout the refurbishment period. Site inspection will be done from time to time and if not in a tidy and safe condition, it must be restored immediately to the satisfaction of ATNS representative. The ATNS representative may order the contractor to stop all work, until such time as, in his opinion, this condition has been observed.
