1. PURPOSE OF THE REQUEST FOR QUOTATIONS

2.1 SCOPE OF WORK

The successful service provider will be required to provide the following:

- Structural Engineer for Inspection, reporting and recommendation.
 - The Radar Pedastil floor has started developing cracks and the reinforcement steel bars/rods have started showing signs of rust and are causing the walls to crack.

The contractor will only be issued with a site access certificate once his SHE file has been approved and accepted by ATNS. It is therefore of utmost importance that the SHE files gets approved before any delivery to site is considered, to prevent unnecessary delays and standing time at the Airport entrance gate.
