- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe and cost-effectiveness for ATNS.

#### 2. EXTENT OF WORK

## **Strategy Development**

- Conceptualise the nature and importance of strategy and strategic planning
- Critically analyse and evaluate the ATNS environment and identify global and local opportunities and threats, taking into account the organisation's internal capabilities and resources and the context in which the organisation operates.
- Evaluate the strategic alternatives available to ATNS and advise Executives and the Board on alternatives (scenario planning).
- Evaluate the impact of ATNS strategic choices and advise the Executive and the Board on appropriate structures and controls that will be required for implementation of the selected strategy.

### **Theory of Change**

ATNS requires accredited Service Providers to design, develop, and implement a Theory of Change Course at **NQF Level 9** to equip its leaders with the skills to apply the Theory of Change as a tool for the development of Strategic Plans and Annual Performance Plans. The course must also provide the leaders with key concepts and guidance on how to apply the Theory of Change logical framework to stimulate thinking through the application of these concepts in the ATNS environment. At the end of the course, the leaders must be able to:

- Contextualise planning management processes in Strategic Planning.
- Conduct a situational analysis with Strategic Management tools and evaluation instruments to identify priorities and formulate key actions applicable to Strategic Planning.
- Apply the Theory of Change process to build value chains and understand what change the execution of the strategy will bring to the organisation
- Plan for the implementation of the ATNS Corporate Strategy through the application of a Logical Framework.



### **Strategic Project Management**

ATNS requires accredited Service Providers to design, develop, and implement a Strategic Project Management course to equip its leaders with the skills to implement corporate strategy through a strategic project management vehicle that comprises portfolios, programmes and projects with EPPMO and PMO as implementation structures. At the end of the course, the leaders must be able to:

- Have a deep understanding of the ATNS strategic environment (external and internal) as it impacts strategy implementation.
- Contextualise the ATNS EPPMO and PMO within the strategic context of the organisation, and alignment of Portfolios, Programmes and Projects.
- Formulate strategic-level project schedules and plans within the framework for time, cost, quality and strategic trade-offs.
- Recommend leadership approaches to effectively manage projects through people by addressing challenges related to team and organisational dynamics, interpersonal conflict and communication, and performance-related coaching of project team members.
- Utilise the dynamic change management framework to lead projects as change.

#### 1. Documentation and Control

Documentation to be generated as part of the contract shall be the responsibility of the contractor.

Inspections will be carried out by the ATNS representative in order to ensure that the works is carried out to satisfaction and in line with the Work Specification and the method statement provided by the Tenderer and accepted by ATNS.

## a. SAFETY (IF SUPPLIER IS GOING TO WORK AT THE AIRPORT)

On appointment the successful tenderer must submit a SHE file complying with the latest amendment of the Occupational Health and Safety Act and Regulations. The contractor will only be issued with a site access certificate once his SHE file has been approved and accepted by ATNS. It is therefore of utmost importance that the SHE files gets approved before any

delivery to site is considered, to prevent unnecessary delays and standing time at the Airport entrance gate.

Minimum site SHE files requirements (also refer to OHS Act and Regulations):

- · Site specific risk assessment
- · Site specific method statement
- Waste Management Plan
- Valid medical certificate of fitness for all employees on site, issued by an occupational health practitioner.
- Environmental Method Statement
- Proof of Competency for the duly appointed competent staff on site.
- Records of the health and safety induction training pertaining to the site
- · ID copies for employees on site
- The PPE register for the site essential PPE, i.e., life jackets, safety harness, etc., issued to employees on site.
- Letter of good standing with the Department of Labour in terms of the Compensation fund
- Any other certificates relevant to the site and activities to be carried out.

The successful tenderer will be responsible for the site to be in a safe and tidy condition throughout the refurbishment period. Site inspection will be done from time to time and if not in a tidy and safe condition, it must be restored immediately to the satisfaction of ATNS representative. The ATNS representative may order the contractor to stop all work, until such time as, in his opinion, this condition has been observed.

#### b. ACCOMMODATION

No accommodation camp can be set up at the sites; the Contractor must make his/her own arrangements for staff accommodation, should that be required.
