The objective of this bid is to appoint a suitable UPS system service provider that can provide assurance to ATNS Management in discharging its responsibilities regarding UPS systems. The bidder must demonstrate the capability to perform effective servicing, maintenance and testing of UPS systems in accordance with all legal, statutory and manufacturer requirements.

Scope of Servicing, Maintenance & Repairs to UPS systems

The successful service provider will be required to perform the following services:

- Development of the risk based three year rolling plan for servicing, maintenance & testing of UPS at the following sites;
- Services including but not limited to the following
 - Check and record Battery capacity on arrival.
 - Check and record Battery capacity under load, REPLACE if required.
 - Check AC and DC fans, REPLACE if required
 - Check rectifier for correct operation, REPLACE if required.
 - Check DC caps, REPLACE if required.
 - Clean and dust inside and outside.
 - Check signage and instructions for switch on/off procedure, REPLACE if required.
 - Check signage and instructions for wrap around bypass, REPLACE if required.
- Execution and maintenance of the UPS service plan;
- Annual compliance audits;
- Attendance and reporting to the ATNS FACT Management on an annual basis any significant findings identified.
- Transfer skill to the ATNS in-house staff during maintenance and Annual Training (2-3 days on site)
- The performance of any other ADHOC requirement requested by management on quotation basis.
- Scheduled replacement of batteries according to design life and condition. Battery replacement will be quoted for by contractor separate to fixed maintenance cost.
- Replacement of DC Caps, AC and DC fans and rectifiers will be quoted for by the

contractor separate to the fixed maintenance cost.

In describing the understanding of work to be done, the potential service provider will:

- Explain their approaches to performing UPS system service, including audit methodology, nature, timing and extent of approaches to be followed;
- Demonstrate experience and expertise of UPS system service and compliance with applicable laws and regulations;
- Provide details of the core team;
- Maintain the core team throughout the duration of the contract.

All UPS service reports and working papers shall remain the property of ATNS. In carrying out the work, the successful service provider must ensure that staff will obtain and

maintain ACSA permanent permits for access to airside.

The contractor shall perform any other duties related to UPS maintenance on quotation bases as and when requested by ATNS management.

Inspections will be carried out by the ATNS representative in order to ensure that the works is carried out to satisfaction and in line with the Work Specification and the method statement provided by the Tenderer and accepted by ATNS.

a. SAFETY (IF SUPPLIER IS GOING TO WORK AT THE AIRPORT)

On appointment the successful tenderer must submit a SHE file complying with the latest amendment of the Occupational Health and Safety Act and Regulations. The contractor will only be issued with a site access certificate once his SHE file has been approved and accepted by ATNS. It is therefore of utmost importance that the SHE files gets approved before any delivery to site is considered, to prevent unnecessary delays and standing time at the Airport entrance gate.

Minimum site SHE file requirements (also refer to OHS Act and Regulations):

- Site specific risk assessment
- Site specific method statement
- Waste Management Plan
- Valid medical certificate of fitness for all employees on site, issued by an occupational health practitioner
- Environmental Method Statement
- Proof of Competency for the duly appointed competent staff on site
- Records of the health and safety induction training pertaining to the site
- ID copies for employees on site
- The PPE register for the site essential PPE, i.e., life jackets, safety harness, etc., issued to employees on site
- Letter of good standing with the Department of Labour in terms of the Compensation fund
- Any other certificates relevant to the site and activities to be carried out

The successful tenderer will be responsible for the site to be in a safe and tidy condition throughout the refurbishment period. Site inspection will be done from time to time and if not
