1. SECTION A: INTRODUCTION AND SCOPE OF WORK

1.1. INTRODUCTION

- Air Traffic and Navigation Services SOC Limited (ATNS) provides air traffic, navigation, training and associated services within South Africa and a large part of the Southern Indian and Atlantic Ocean, comprising approximately 6% of the world's airspace.
- ATNS operates from nine ACSA and 12 other aerodromes. As a globally competitive employer of choice, ATNS is committed to diversity and has achieved ranking within the top 10 companies in South Africa with regards to female representation at executive levels.

1.2. OBJECTIVE OF THE REQUEST

1.2.1. APPOINTMENT OF AN EXPERIENCED SERVICE PROVIDER TO REPAIR AND CERTIFY THE RADAR HOIST AT THE AVIATION TRAINING ACADEMY

1.3. SCOPE OF WORK

1.3.1 Removal and replacement of a lifting beam

- Remove the damaged hoisting boom from the ATA radar tower, located 13 meters above the ground.
- Repair or replacement of the monorail "I" beam to a 500 Kilogram capacity at the end stop.
- Paint and mark the beam as per SANS requirements.
- Reinstallation of the hoisting boom on the ATA radar tower, including the beam trolley and securing eye bolt.



1.3.2 Load testing and certification

- Load testing of the boom and beam trolley to hold a minimum of 250 kilograms at the end stop, in line with South African National Standards.
- Load testing of the existing electric chain hoist to lift a minimum of 250 kilograms at the boom stop, in line with South African National Standards.
- Issue a certificate of compliance for the load testing of both the boom and the hoist. As per SANS legal requirements.

1.3.3 SANS 10375 certification is required.

1.4 VALIDITY PERIOD

1.4.1 The proposal provided to ATNS in terms of this request for quotations will be valid for a period of **60 days** from the date of submission except for the Tax and B-BBEE certificates which must still be valid at the time of award.

1.4.2 Should there be a need to request extension of the finalisation of the award of the RFQ, the bidders will be duly informed, and the priced proposal will remain valid for the amended duration.

1.5.1 The closing date and time for submitting quotations is 19 September 2024 @ 10h00, CAT.
