2. SECTION B: BID EVALUATION PROCESS

Bid Evaluation Process

The bid evaluation process for this RFQ will be conducted in two (2) distinct stages as follows:

2.1. Stage 1: Required Returnable and Administrative Requirements

All prospective bidders must comply with the following administrative requirement:

- 2.1.1.** Must be registered on the National Treasury CSD (Central Supplier database): A full report must be submitted.
- 2.1.2.** Completed ATNS Pricing Schedule.
- 2.1.3.** Tax clearance certificate and Pin, bank confirmation letter, BEE certificate or sworn affidavit, and CIPC registration documents
