#### PURPOSE OF THE REQUEST FOR QUOTATIONS

- 1.1 Air Traffic and Navigation Services SOC (herein this document referred to as "ATNS") seeks to identify and appoint suitably experienced, qualified, and accredited training service provider for the provision of International Accounting Standard 36 (IAS 36) Training.
- The purpose of this RFQ is to contract with a suitably qualified supplier with specific 1.2 product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe, and cost-effectiveness for ATNS.

#### 2. **EXTENT OF WORK**

#### 2.1 **SCOPE OF WORK**

The service provider should be suitably experienced and accredited by a relevant accreditation institution to offer the following training:

International Accounting Standard 36 Impairment of Assets (IAS 36)

The project should cover the following:
