ANNEXURE A: SCOPE OF WORK

1. **PURPOSE OF THE REQUEST FOR QUOTATIONS**

- 1.1 Air Traffic and Navigation Services SOC (herein this document referred to as "ATNS") seeks to identify and appoint suitable supplier for the provision of Mould Treatment Services to ATNS King Phalo Airport (East London) for a period of twelve (12) months.
- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe, and cost-effectiveness for ATNS.

2. EXTENT OF WORK

2.1 SCOPE OF WORK

The service provider is to provide a comprehensive mold treatment service which include but to be limited to the following activities:

- Disinfecting accumulated germs, removing of mold from walls and mats in the ATNS offices including passages and furniture quarterly and as and when needed for one year.
- The mold treatment must at least last for three months.
- Total area to be cleaned in square meters = 400 square meters
- Number of offices = 8
- All chemicals to comply with SABS standards and norms and they should be used in accordance with manufacturer's instructions. Material Safety Datasheet to be provided for each chemical.
- All mold treatments to be done by qualified persons.


