1. PURPOSE OF THE REQUEST FOR QUOTATIONS

- Air Traffic and Navigation Services SOC (herein this document referred to as "ATNS") 1.1 seeks to identify and appoint suitable supplier to provide refurbishment of a Science Laboratory at Thethe Secondary School – North-West Province.
- 1.2 The purpose of this RFQ is to contract with a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe, and cost-effectiveness for ATNS.

2. EXTENT OF WORK

2.1 **SCOPE OF WORK**

Based on the current status of the science lab, the following scope of work is proposed in order to upgrade the lab so that it can function at the level required by the school.

The scope of this project shall entail the following main aspects:
