1. PURPOSE OF THE REQUEST FOR QUOTATIONS

- 1.1 Air Traffic and Navigation Services SOC (herein this document referred to as "ATNS") seeks to identify and appoint suitable supplier for the supply and delivery of heavy duty metal cage for a housing container for leeuwkop VHF site located at 180 kilometers from Johannesburg on the N3 towards Harrismith, Close to SAPS Roadside Police Station .
- 1.2 The purpose of this RFQ is to contract a suitably qualified supplier with specific product knowledge and the requisite capacity to execute this project within the desired quality, scope, timeframe, and cost-effectiveness for ATNS.
- 1.3 Supply, deliver and install heavy duty metal cage with a heavy duty metal padlock protector on the locking system for a housing container for Vryburg VHF site that is located in vryburg.
