#### 1 INTRODUCTION

#### 1.1. Company Background

The Air Traffic and Navigation Service Company Limited (ATNS) is a State-Owned Company (SOC), established in 1993 in terms of the ATNS Company Act (Act 45 of 1993) to provide air traffic management, communication, surveillance, navigation, training, and associated services within South Africa on behalf of the State. ATNS manages 6% of the world's airspace. These services accord with International Civil Aviation Organisation (ICAO) standards and recommended practices, the South African Civil Aviation Regulations and Technical Standards. As an Air Navigation Service Provider (ANSP), ATNS is governed by the nation's legislative and administrative framework.

ATNS, which has over 1100 employees, endeavours to offer safe airspace as well as orderly, speedy, and efficient Air Traffic Management services on a constant basis. The company operates at 21 aerodromes across the country, including OR Tambo, Cape Town, and King Shaka International Airports.

In the rest of the African Continent, ATNS provides various support services to other ANSPs and Civil Aviation Authorities (CAAs) amongst others the Aeronautical Satellite Communication (based on VSAT technology) networks.

This service extends from Cape to Cairo interconnecting more than 33 states in Africa and Middle East. Other services include Air Traffic Services (ATS) and technical training, World Geodetic System (WGS) 84 surveys, airspace design, obstacle evaluations, Aeronautical Information Publication (AIP) documentation, Billing, and consultancy services.

#### 1.2. Purpose of the EOI

- 1.2.1. The objective of this EOI is to facilitate Enterprise Development (ED) and Supplier Development (SD), which are two of the three priority components of the Broad-Based Black Economic Empowerment (B-BBEE) Scorecard. The goal of Enterprise Supplier Development (ESD) is to strengthen local procurement, improve local supplier development programmes, and expand financial support for black businesses.
- **1.2.2.** ATNS pursues Preferential Procurement (PP) as stipulated in the B-BBEE legislation to address issues of transformation within the aviation sector. This is also done to ensure that ATNS remains B-BBEE complaint and contributes towards the transformation agenda.
- **1.2.3.** ESD is therefore undertaken in alignment with the key performance indicators as defined by the Department of Transport (DoT) Transformation Strategy.
- 1.2.4. To establish strategic partnerships for the execution and delivery of projects or ongoing services within South Africa and the African Indian Ocean Region, ATNS invites Small, Medium, and Micro Enterprises (SMMEs) to express interest in this programme by providing information.
